City Timetable for 203 Crossington for law enforcement training exercises

The City of Troy applied Article 37 of Drug Forfeiture Law to take possession of house.

Law Enforcement Committee (consists of 3 Alderman from the City of Troy) recommended to vacate training at 203 Crossington Lane and prepare for sale. Mayor Adomite said that the plan is for training exercises to end at the end of July, 2017. The City would take the following two months to get the property ready for sale with the goal of putting the property on the market by the end of September.

Julie Knopf mentioned that some street lights seemed dim and asked if they could be replaced – Jeff Soland (City Administrator) said he could speak with Ameren regarding street lamps.

Street Repairs – roadway needs repair work near 100 Fairington.

Video Surveillance Systems

The Mayor mentioned that residents in Troy are having success with Ring Technology. The City may be able to help residents with discounts through Troy Police Department.

Emily Sauget asked if the City could spray for mosquitos until the creek project is finished. The City does not currently spray for mosquitos in Troy. Leslie Bednar & Mark Hendrickson mentioned that they use Mosquito Joe to spray for Mosquitoes. Ed Foppe mentioned that the HOA would contact Mosquito Joe to see about getting group rates for residents that would be interested.

Residents expressed interest in having a block party. Ed Foppe asked for volunteers who would be interested in helping the HOA in organizing a block party. Jennifer Brown Ridenour, Paul Schroth, and Tracy Butler said they would help with a block party committee. No scheduled date determined at this time.

Review of creek reconstruction plans

Project ends at the property of 100 Fairington.

Discharge Pipe being extended from the Sauget's yard (144 Fairington Drive) to the rear corner of the Warren's property (8 Shadesrest Court) which will help to raise the level of the bottom of the creek and make the overall creek shallower. There are also new design elements including a separate 10" diameter pipe that will run underground the length of the creek run to carry a significant portion of the water in rain events. There will be catch basins along the creek that will also flow into this 10" pipe.

Easement documents have been delivered to residents. Deadline for returning easement documents to the City is July 18, 2017. Failure of all residents to return signed easement documents to the City by 7/18/17 may eliminate potential funds available from Heartland Conservancy for this project. A retention pond will be constructed at the entrance of this creek outside of the Fairoaks neighborhood. Soil sampled showed that this retention pond will not be lined. The soil will just have to be compacted.

Due to Heartland Conservancy Grant requirements work on the creek reconstruction may start as early as April/May of 2018. The expected length of the construction project is expected to be 2-3 months. The City's fiscal budget starts May 1st. The Mayor is planning that the City's portion for this project will go in to the City's budget from 5/1/18—4/30/19.
